WHERE	Rob Nay Memorial Pool, Beenleigh		
TRANSPORT	We will be transporting the students by bus to and from the venue.		
	These buses are fitted with seat belts.		
WHAT TO BRING	Students attending are to wear their swimming attire underneath their		
	full school uniform as classes will be departing at 9am.		
	In a separate bag, students need to ensure they have a towel, swimming		
	cap, sunscreen and spare underwear. Goggles are recommended but		
	not compulsory. Please ensure all items are named.		
	Once the water safety day has concluded, students will change into		
	their school uniform at the pool.		
	As students will be at the pool for the majority of the day, students		
COCE	must have a packed lunch and a water bottle.		
COST	This year, our school and Queensland State Government has helped		
	subsidised the cost making the total cost \$29 (original cost \$55). This		
	price includes including lessons and transport.

### Dear Parents/Caregivers

We are excited to offer your child/ren the opportunity to take part in the Water Safety Program.

Please note the following important information about the program

- This program will only take place if sufficient interest is indicated by the due date for payment. Payments will be refunded in full should the program not go ahead.
- Your child's attendance is dependent on their behaviour at school this term. Students considered high risk will not be permitted to attend the excursion, as we put the safety of our students above everything else.

- Students attending need to ensure they have all the appropriate attire and equipment for lessons
- A medical certificate must be provided in order to claim a refund. A refund may or may not be granted. The cost of the bus is always non-refundable. If your child is excluded due to behavior issues no refund can be claimed.
- Student Resource Scheme payments must be up to date for students to be eligible to participate in camps, excursions and incursions.
